DEVELOPMENTS FROM THE WORLD ABOUT THE PROTECTION OF PERSONAL DATA

PUBLISHED GUIDES AND WORKS

1. Information Commissioner's Office (ICO) has published two guide reports that indicates the usage of "immature biometric technologies" may lead to discrimination and that the use of emerging technologies.

ICO, while talking about the risk assessment that organizations that will use the relevant technologies should do before using these systems, stated that the use of these systems poses a risk and the organizations that neglect to make the necessary assessments will be examined.

2. International Commissioner's Office (ICO) has published a guide which is named "Legal and Proper Use of Artificial Intelligence and Personal Data".

In the relevant Guide; steps on how artificial intelligence and the way personal data is handled can be improved and frequently asked questions about artificial intelligence and personal data.

3. A guide named "Ethical Rules About Use of Artificial Intelligence" has been published by the European Commission regarding to educational environments.

4. A study named "Artificial Intelligence Dictionary Which Centered Human" has been published by the European Commission's Joint Research Center.

5. European Data Protection Board (EDPB) have released a guide for public opinion which is about the data breach notifications under GDPR.

At the guide: the "notification requirements regarding data breaches in non-EU organizations" had been amended and an opinion was requested specifically on this section.

COURT DECISIONS:

1. Singapore High Court ruled a decision which stated that NFT's can be a subject of property.

It was ruled by the court that NFT's can be easily distinguished from each other and can be subject to ownership if they meet a number of legal obligations, such as ownership that can be recognized by third parties.



2. The Court of Justice of the European Union (CJEU) has decided that data controllers should take reasonable steps to notify internet search engine providers of deletion request applications made by the relevant persons.

In the relevant decision; it is stated that the data controller, in line with the technical and administrative measures it has taken, should inform the other data controllers to whom personal data are provided or to whom such data is transferred that the data subject has withdrawn its explicit consent to the processing of the personal data. An important point stated in the decision is that in cases where there are multiple data controllers who process data based on the explicit consent of the data subject, it is sufficient for the data subject to apply to one of the data controllers.



OTHER NEWS

1- The Second International Anti-Ransomware Initiative (CRI) Summit was held at the White House.

At the end of Summit, it has been decided to create an international duty force intand to International Counter Anti-Ransomware Task Force (ICRTF).

2- The Digital Services Act was published in the Official Journal of the European Union dated 27.10.2022.

Aim of this Act which is digital services provider and included online platforms; in order to ensure the protection of fundamental rights of cunsomers, it determined obligations and liabilities of service provider and online platform.

3- The Luxembourg National Data Protection Commission (CNPD) became the first data protection authority to accredit a certification body under the European Union General Data Protection Regulation (GDPR).

4- The International Organization for Standardization (ISO) announced the update of the "ISO / IEC 27001: 2022 Information Security, Cyber Security and Privacy Protection" standard.
